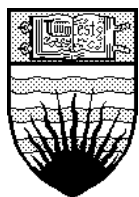

NOTE: We request that completed forms be accompanied by a personal statement of not more than 250 words to be made available to prospective voters in support of the nominee's candidacy. The use of hyperlinks in these statements is not permitted. Statements are to be written in the first person and submitted no later than the deadline below.

Each nominee is requested to provide the Registrar with the following supplemental information along with their nomination form, if applicable:

- i. The candidate's academic and honorary degrees;
- ii. The candidate's current occupation;
- iii. The candidate's current and past academic, societal, governmental, or commercial offices held;
- iv. The candidate's current professional or business interests; and
- v. The candidate's list of publications (if any).

Enrolment Services must receive completed nominations by 4:00 pm on Friday, October 9, 2020. Late submissions will NOT be accepted. Receipt of all nominations will be confirmed within two business days of the close of nominations.

If required, voting is expected to occur in early-November 2020.
